## Terms and conditions

1. Entries for the 'The Essence of St Kilda' Photography Prize 09 will be considered from still photo-based analogue and digital media.
2. Work/s of A3 size (297 x 420mm) only, will be considered
3. Only images taken within the St Kilda Village as defined by the white streets on the map displayed on [stkildavillage.org.au](http://stkildavillage.org.au)
4. Each entrant may submit up to 3 different images each attracting a separate entry fee of \$25.00.
5. Entries will be judged in PRINT form only. Judges will select one work only for exhibition from each chosen finalist.
6. Entries must include up to 3 different digital images on CD (Jpeg 300dpi or TIFF) and an A3 print/s to be considered for the exhibition.
7. The closing date for entries is **5pm on Friday 26 June 2009**
8. Entries must be delivered to the **Vineyard Restaurant, 71a Acland Street on Tuesdays to Fridays between the hours of 1-6pm and handed to Johnny Iodice in a sealed envelope marked ST KILDA VILLAGE PHOTOGRAPHY PRIZE 2009 and contain: the entry form, payment, A3 photo and cds.**
  - Each CD must be clearly marked in permanent marker with the artist's name and a title of work/s as well as the location and date where each was taken. Do not use adhesive labels. Each photo must also be clearly marked on its reverse
  - Maximum number of images entered per photographer is 3 - but feel free to submit more of your images free of charge for the [stkildavillage.org.au](http://stkildavillage.org.au) gallery.
9. Any entry not accompanied with payment of the entry fee will be deemed ineligible.
10. Payment of entry fee may be made by cheque, money order or netbank payment to St Kilda Village Traders' Group Inc. Netbank details - **Account name:St Kilda Village BSB:033-082 Account:13-8732.** Receipt of payment must accompany entry.

11. Members of the SKVTG committee and employees of the SKVTG or the organiser and members of their immediate family are ineligible to enter.
12. The judges will award a cash prize to the value of \$1000 to the winning work, \$750 for the second prize and \$500 for the people's choice.
13. **Copyright of all the photographs exhibited will remain with the artist. It is a condition of entry however that entrants grant the SKVTG the right to freely use and reproduce all exhibited works for publicity and promotional purposes associated with the Essence of St Kilda Photography Prize 09 in both digital and print mediums.**
14. Final judging will take place prior to the works being installed for exhibition. The winners will be announced on Wednesday 29 July at the Exhibition Launch. Venue to be confirmed. Prize winners will be announced on the **stkildavillage.com.au** website. Winners will also be notified via email and phone after judging has taken place.
15. All decisions of the judges are final, and not subject to review.
16. The image/s submitted must be an original creation of the artist submitting the image.
17. Works may be collected from the Vineyard Restaurant from 16-18<sup>th</sup> September 2009 between the hours of 1-4pm.
18. If an artist fails to remove a work from the Vineyard Restaurant by 18<sup>th</sup> September 2009, the work becomes the property of SKVTG. Thereafter the SKVTG shall be under no liability to the artist in respect of any work.
19. All personal information gathered by SKVTG will be used solely for the purpose of administering 'The Essence of St Kilda Photography Prize 09'.
